Welcome to Perimeter 81 Black Hat 2022 Sweepstake Promotion! (the "Promotion")

**ELIGIBILITY:** This Promotion is open only to legal residents of the United States who are 21 years of age or older. Employees, officers, and directors of Perimeter 81, Ltd.
